## GENERAL RULES AND REGULATIONS

Intending Exhibitors and Competitors are particularly requested to peruse these Rules and Regulations carefully in addition to the Special Conditions applicable to the various classes and competitions. Entries are accepted from Exhibitors and Competitors who are allowed to compete only on the clear understanding that they agree to comply with and be bound by these Rules and Regulations and the Special Conditions relating to each class or competition.

1. Late or nomination entries will not be accepted. All entries must be sent to The Secretary, All England Jumping Course, Hickstead, Sussex RH17 5NU, together with the correct amount of entry fees.
2. **MEDICATION CONTROL PROGRAMME (MCP Levy)** The F.E.I. have imposed a levy of SFR 25 (£18) per horse per show to be paid at the time of entry. This levy applies only to those horses entered in international classes.
3. **SHOWJUMPING EXHIBITORS PASSES** Owners and riders of horses in the jumping classes must be members of Hickstead where applicable, and will receive one groom & wristband per two horses, plus a horsebox pass for parking in the Stable Field. Passes will only be issued to exhibitors for the day they are exhibiting. Weekly stabling does not entitle exhibitors to a full quota of weekly passes - only one weekly Groom & Wristband will be issued free of charge. Extra passes will need to be purchased. Exhibitors and visitors parking in the Riders & Car Park at the top of the Stable Field near the exit will be charged £10 per day or £30 for the week. Car Passes can be purchased in advance or on the day.

4. **FORAGE AND SHAVINGS** are available for purchase at Hickstead in the Stable Field, or exhibitors may bring their own. Deliveries of forage and bedding from alternative suppliers will be **strictly prohibited this year**. It is regretted that straw is banned from the Stable Field due to Fire Regulations.
5. **FORFEITURE OF FEES AND CHARGES** Failure to exhibit any animal entered will entail forfeiture of entry fees and all other charges other than in accordance with British Showjumping rules. Should any competition be cancelled because of bad weather or any reason, entry fees will be refunded. It is regretted that stabling and other charges cannot be refunded.
6. The Executive reserves the right to use images of competitors at Hickstead for any promotional purpose.
7. The Executive reserves the right to cancel, add to, or amend any of the competitions as they think fit.
8. The Executive reserves the right to remove any vehicle which is obstructing any access to or on the ground even if locked and unattended and the Executive will not be liable for injury, loss or damage occasioned by such removal.
9. In Jumping Competitions all horses and ponies must be registered with British Showjumping and be the property of, and ridden by, members of that Association. If an animal is up-graded before a competition he may be transferred upon notice to the Executive to another appropriate competition.
10. Any competitor found riding in any of the rings without permission will be disqualified from the show and reported to the Stewards of British Showjumping. All warming up must be done in the area provided.
11. Neither the All England Jumping Course nor the Executive nor Hickstead Limited nor any of them nor any of its or their officers, servants or agents shall be in any way liable for any accidents, injury, damage, loss or for anything that may happen (from any cause or circumstances whatever) to exhibitors, competitors or members of their servants, agents or to anyone on the show ground or to any animal or article exhibited or to any property brought on to the show ground or for any other loss, claim, matter, circumstances or event whatsoever in connection with, or arising out of, or attributable to the show or any journey to or from the show, the Executive of Hickstead Limited or any of them or its or their officers, servants or agents of these or any other Rules and Regulations or Special Conditions prescribed by them.
12. **THE EXECUTIVE MAY IN ANY DISPUTE OR OTHER MATTER WHATSOEVER, ACT OR DECIDE IN ANY MANNER THEY THINK FIT (SAVING BRITISH SHOWJUMPING RULES).**
