GENERAL RULES AND REGULATIONS

Intending Exhibitors and Competitors are particularly requested to peruse these Rules and Regulations carefully in addition to the Special Conditions applicable to the various classes and competitions. Entries are accepted from Exhibitors and Competitors who are allowed to compete only on the clear understanding that they agree to comply with and be bound by these Rules and Regulations and the Special Conditions relating to each class or competition.

1. EXHIBITORS PASSES. Exhibitors in the Showing Classes will receive two membership badges (one for the owner and one for the rider), plus a Horsebox Pass for parking in the Stable Field. One groom's wristband will be allocated per two horses. Passes will only be issued to exhibitors for the day they are exhibiting. Weekly stabling does not entitle exhibitors to a full quota of weekly passes. Extra passes will need to be purchased: only one weekly groom's wristband will be issued per two horses free of charge.

Exhibitors' passes are valid the day before their classes when overnight stabling is booked. Access is limited to Stable Field only, and to the Showground, Trade Stand Village and Food Hall from 4.00pm. Exhibitors may purchase extra passes in advance from the Hickstead Office. Exhibitors and visitors parking in the Riders' Car Park at the top of the Stable Field near the exit will be charged £10 per day or £40 for the week. Car Passes can be purchased in advance or on the day (please send remittance with entry form) as follows:

2. SHOWING EXHIBITORS' NUMBERS will be mailed together with the Exhibitor Passes.

3. FORAGE AND SHAVINGS are available for purchase in the Stable Field, or exhibitors may bring their own. Deliveries of forage and bedding from alternative suppliers will be strictly prohibited this year. It is regretted that straw is banned from the Stable Field due to Fire Regulations.

4. Late or nomination entries will not be accepted. All entries must be sent to The Secretary, All England Jumping Course, Hickstead, Sussex RH17 5NU, together with the correct amount of entry fees.

5. SUBSTITUTION OF ENTRIES will not be accepted in Showing classes.

6. FORFEITURE OF FEES AND CHARGES Failure to exhibit any animal entered will entail forfeiture of entry fees and all other charges. Should any competition be cancelled because of bad weather or any reason, entry fees will be refunded. It is regretted that stabling and other charges cannot be refunded.

7. The Executive reserves the right to use images of competitors at Hickstead for any promotional purpose

8. The Executive reserves the right to cancel, add to, or amend any of the competitions as they think fit.

9. The Executive reserves the right to remove any vehicle which is obstructing any access to or on the ground even if locked and unattended and the Executive will not be liable for injury, loss or damage occasioned by such removal.

10. Any competitor found riding in any of the rings without permission will be disqualified from the show. All warning up must be done in the area provided.

11. Neither the All England Jumping Course nor the Executive nor Hickstead Limited nor any of them nor any of its or their officers, servants or agents shall be in any way liable for any accidents, injury, damage, loss or for anything that may happen (from any cause or circumstances whatever) to exhibitors, competitors or members or their servants, agents or to anyone on the show ground or to any animal or article exhibited or to any property brought on to the show ground or for any other loss, claim, matter, circumstances or event whatsoever in connection with, or arising out of, or attributable to the show or any journey to or from the show, the Executive of Hickstead Limited or any of them or its or their officers, servants or agents of these or any other Rules and Regulations or Special Conditions prescribed by them.

12. THE EXECUTIVE MAY IN ANY DISPUTE OR OTHER MATTER WHATSOEVER, ACT OR DECIDE IN ANY MANNER THEY THINK FIT.
