GENERAL RULES AND REGULATIONS

Intending Exhibitors and Competitors are particularly requested to per use these Rules and Regulations carefully in addition to the Special Conditions applicable to the various classes and competitio ns. Entries are accepted from Exhibitors and Competitors who are allowed to compete only on the clear understanding that they a gree to comply with and be bound by these Rules and Regulations and the Special Conditions relating to each class or competition

1. All entries must be sent to The Secretary, All England Jumping Course, Hickstead, West Sussex RH17 5NU, together with the correct amount of entry fees.
2. **FORFEITURE OF FEES AND CHARGES** Failure to exhibit any animal entered will entail forfeiture of entry fees and all other charges other than in accordance with British Showjumping rules. Should any competition be cancelled because of bad weather or any reason, entry fees will be refunded. It is regretted that stabling and other charges cannot be refunded.
3. Teams must jump in the order in which they appear in the programme, unless special permission has been obtained from the Executive.
4. During the competition **THREE TEAMS MUST ALWAYS BE READY TO ENTER THE RING** . If a team does not respond when it is called, it loses its turn, and may be eliminated from the Competition in progress.
5. The Executive reserves the right to cancel, add to, or amend any of the competitions as they think fit.
6. The Executive reserves the right to remove any vehicle which is obstructing any access to , or on the showground even if locked and unattended , and the Executive will not be liable for injury, loss or damage occasioned by such removal.
7. **HORSEBOXES** - It is a requirement to put your mobile telephone number on your horsebox pass which must be displayed in the windscreen. It is prohibited for any exhibitor or associate to interfere with another exhibitor's horsebox.
8. **SHAVINGS** are available for purchase at Hickstead in the Stable Field, or exhibitors may bring their own. It is regretted that straw is banned from the Stable Field due to Fire Regulations.
9. Any competitor found riding in the ring without permission will be disqualified from the show. All warming up must be done in the area provided.
10. Neither the All England Jumping Course nor the Executive nor Hickstead Limited nor any of them nor any of its or their officers, servants or agents shall be in any way liable for any accidents, injury, damage, loss or for anything that may happen (from any cause or circumstances whatsoever) to exhibitors, competitors or members or their servants, agents or to anyone on the show ground or to any animal or article exhibited or to any property brought on to the showground or for any other loss, claim, matter, circumstances or event whatsoever in connection with, or arising out of, or attributable to the show or any journey to or from the show, the Executive of Hickstead Limited or any of them or its or their officers, servants or agents of these or any other Rules and Regulations or Special Conditions prescribed by them.
